AGREEMENT FOR INTERIM SUPERINTENDENT SUPPORT SERVICES FOR THE DIXIE SCHOOL DISTRICT

This Agreement for Interim Superintendent Services for the Dixie School District is by and between the Dixie School District (hereinafter referred to as the "District") and the Marin County Superintendent of Schools (hereinafter referred to as the "Superintendent").

The parties agree as follows:

1. The Superintendent will provide the District with the following individual who will provide Interim Superintendent services as follows:
 - a. Rebecca Rosales at .8 full time equivalent (FTE), the equivalent of 186 work days;
2. The District shall reimburse the Superintendent for the following costs:
 - a. For Daily rate of service as described in Exhibit A attached which includes:
 - i. Health and welfare
 - ii. Payroll driven costs (taxes, retirement)
 - iii. Monthly car allowance
 - iv. 5% indirect administrative fee
 - b. Daily rate of service for up to 9 days of claimed sick leave and any mandated leaves of absence; and
 - c. Any actual/necessary costs incurred by the Interim Superintendent while working for the District.
3. A work calendar for this position will be mutually developed and may be modified periodically with the consent of both parties.
4. The term of this Agreement is July 1, 2019 through June 30, 2020.
 - a. Either party may terminate this Agreement without cause upon 60 days written notice. In the event such notice is given, the District shall reimburse the Superintendent for all costs incurred to the point of termination.
5. Both parties agree to meet as needed to review the services provided pursuant to this Agreement.
