**RESOLUTION OF THE BOARD OF TRUSTEES OF THE DIXIE SCHOOL DISTRICT
REGARDING A PROPOSED NAME CHANGE FOR THE DISTRICT**

WHEREAS, on June 25th, 2019, the District received a petition proposing that the District change its name to Kenne Elementary School District, (“Petition”) pursuant to Education Code section 35001. A true and correct copy of the Petition is attached hereto as Exhibit A, and is incorporated by reference;

WHEREAS, on June 26th, 2019, the District submitted a true and correct copy of the Petition to the Marin County Elections Department;

WHEREAS, on June 27th, 2019, the District received a written certification from the Marin County Elections Department, certifying that the Petition contained the minimum fifteen (15) qualified signatures as required by Education Code section 35001 (“Certification”). A true and correct copy of the Certification attached hereto is Exhibit B;

WHEREAS, on June 27, 2019, the District posted the petition on the District’s website;

WHEREAS, on July 9th, 2019, the District’s Board of Trustees held a public hearing to receive community input and consider the Petition in accordance with Education Code section 35001; and

THEREFORE, the Dixie School District Board of Trustees voted to GRANT/DENY the adoption of the petition on July 9th, 2019, by the following vote:

To the Trustees of the Governing Board of the Dixie Elementary School District:

Pursuant to Ed. Code §35001 the undersigned,

being qualified voters of Marin County and residing in the Dixie Elementary School District,

ask that the name of Dixie Elementary School District be changed to:

Kenne School District

Rationale/Background:

Kenne (pronounced ken-ay)


Kenne is the Coast Miwok word for "one." While the Coast Miwok language is no longer natively spoken, Miwok is an Utian language, related to other California Indigenous languages such as Ohlone. The Coast Miwok inhabited the land that the District now serves. Chief Marin was a Coast Miwok of the Huimen tribe. Marin County and the Marin Islands are named in his honor.

Kenne is a nod to the indigenous, pre-colonial history of our community. It is also a symbolic reference to the fact that our multiple and distinct neighborhoods and four school sites comprise one united school district—and one larger, united community.
