**WHEREAS**, on June 27<sup>th</sup>, 2019, the District received a written certification from the Marin County Elections Department, certifying that the Petition contained the minimum fifteen (15) qualified signatures as required by Education Code section 35001 (“Certification”). A true and correct copy of the Certification attached hereto is Exhibit B;

**WHEREAS**, on June 27, 2019, the District posted the petition on the District’s website;

**WHEREAS**, on July 9<sup>th</sup>, 2019, the District’s Board of Trustees held a public hearing to receive community input and consider the Petition in accordance with Education Code section 35001; and
