Dear Dixie School Board,

I moved to Marinwood since I was 2. I went to Dixie/Miller Creek/Terra Linda. My parents were one of the few Asians in the neighborhood since 1978. Since 2015, my wife and I chose to move back here with our young kids primarily due to the excellent school district. Despite all our choices of where to live, we made this choice in part due to my firsthand experience having gone through the district.

Growing up, I was a minority in the schools. I have one memory of when I was in Dixie and after being dropped off at the bus stop to walk home. Several boys found a shopping cart on the side of the road and started to try to run me over with it. They chased me all the way home. Being an Asian kid in a majority white school, that incident could have been seen as a hate crime. My mom was so upset when I came home crying, and immediately called the principal's office to complain. The principal then setup a meeting where all the parents and kids involved would meet. They resolved it with making sure the kids apologized and in the end, those boys became some of my closest friends through the rest of my school years.

This story may seem commonplace now, but back in the 80s it says a lot about the community that an incident like this was resolved in such a manner. The Dixie School District may have it's problems but in terms of trying to be inclusive of people of all backgrounds, I have to say, this is the kind of memory that comes to mind.

The administration cannot appease everyone, but it has to look at facts. Is there proof that the district was named to honor the confederacy or is it just because of the coincidence of it being named during the Civil War? If the district has tried to be inclusive and work towards bettering equity and inclusion, is a name change going to improve the life quality of any child? My point is that there are many more tangible needs to be met in this school district well before a name change. If it must be changed, however, I would prefer that the community weigh in with the previously voted upon advisory vote. Please do not make this decision in a hasty manner without full community input. Thank you for your time.

Dear Dixie School Board of Trustees,

I submitted a version of the following to the Marin IJ, thank you for reading this one.

Gen Z is defined by kids born between 1996 and 2012 This is the vast majority of children currently in the Dixie School district. When they come of age, how will they feel about being alumni of "Dixie", with its historical racist implications? The Washington Post ran a story on January 17th about this generation and how they are likely to vote in the future.

Pew Research Center, a nonpartisan fact tank, studies demographic trends that shape social issues and opinion. They found that Gen Z is more liberal and inclusive than previous generations. When members of Generation Z reach adulthood, they will be the most educated and the most diverse generation in American history.

My own kids—they are 8 and 12 years old— and their friends are anxious. Why wouldn't they be, when they participate in lockdown drills? When they learn about animal extinctions and the negative impacts of climate change? When they hear about kids in detention centers on the news? These are the harsh realities of the world they will inherit. According to Pew Research, youth are becoming more politically active, and feel more empowered than Generation X, and much more so than baby boomers did. I am convinced that the kids in our community will join their peers across the nation and do better than we have done.

If the Dixie School District name does not change now, there will be another fight to change it in the future: This current attempt is the fourth and most supported. I would assume, based on the research, that a more inclusive local generation will take this under their wing and make the change happen, with less resistance. I do not believe most kids in the district think much about the impact of the name "Dixie". I do believe many of the same kids will move away and return as residents or visitors, with a different perspective. The world is changing whether we like it or not. My 12 year old games regularly (much to my chagrin) online with kids from New Zealand, Mexico, Germany, the UK and even Bangladesh! Demographics are changing and we live in a global village. That change is even coming to Marin.

Words carry weight and they have the power to shape culture. In this modernizing world, holding on to a complicated word like "Dixie" makes us appear antiquated. Some nods to the past are charming, some have historical importance. Although our current name may have some historical importance, I don't believe it adds value to our district. The community is weighing in. Do we want to live in the past or do we want to influence the future? As elected officials you face a difficult decision. I ask you to make history by paving the way for the inevitable.

To our Dixie School Board:

As a minority, you can have a unique experience in life. I am a 40 year old American-born Chinese female. I have lived a bi-cultural life of being both fully American and being fully Chinese, and at the risk of being vulnerable in my community, I wanted to put my family's experience on the table.

My husband who was born in Houston, where his birth certificate, under the category of Ethnicity, says "Yellow", moved to Marinwood when he was 2 years old. He was one of maybe 25 Asian students out of 370 when he attended Dixie more than 30 years ago. Equity and Inclusion were not buzz words back then.

They moved to Marinwood because of its outdoor space and pleasantness as well as it's close proximity to SF Chinatown where my father-in-law opened and ran a popular ginseng shop for nearly 40 years. My father-in-law grew up during war time in China, my mother-in-law was born in and fled North Korea in war time as well. They undoubtedly understood hard times. Due to the neighborhood being majority white and fearing their kids would not "fit in", they chose not to teach their two boys either of their native languages of Chinese or Korean. That decision is one that affects my kids today because their own parents cannot easily teach them their heritage through language.

When my husband graduated Dixie Elementary, Miller Creek Middle, and Terra Linda High he went on to UC Davis where he found it to be a new world because there were so many more people who looked and thought like him. His lifelong best friends, being all Asian, he met when he was exposed to a much more diverse environment than this Marinwood community.

Why am I bringing this up? Because even if you vote to change the name, you will not be able to change the majority white environment. Humans gravitate towards those who understand them and the color of your skin is a first indicator. But that's just what it is, a cursory first indicator, after that people become comfortable with each other as they find commonalities.

I myself have found many commonalities here with those who oppose the name change because of our desire to do what's best for the children and the community as a whole. My respect for those who will stand up for what's right and not just what feels good, despite being a smaller voice in the crowd, has skyrocketed. I appreciate this fight for the sake that I have connected with other like-minded community members who coincidentally do not share my skin color.

It was not easy being the only Asian female speaker at the last school board meeting and I didn't realize my voice would tremble the whole time. But I didn't like the monetary deterrent from the kids education and the misplaced hurt that this issue was causing our community. In the Next Door forums, there has been a blame that white people and "white fragility" are responsible for racist attitudes prohibiting this name change. Blaming white people or white attitudes for racism is ridiculous. To me, racism is human nature veering towards security and comfort and must only be combated by discernment, compassion and courage.

Even if you vote to have the name changed, Equity and Inclusion will not be achieved except by spending time and energy to genuinely speak to someone who doesn't look like us, think like us and maybe even makes us feel a little uncomfortable. Doing all that, while leaving the name the same, might very well bridge the gap that those seeking to change the name are looking for. Thank you very much for taking the time to read my thoughts on this issue.

**At the very least, in an effort to show you want to hear from all of your constituents, even the more quiet and shy ones, please let this community have the opportunity to participate in a colorblind advisory vote before you make this decision.**



Many people have asked why changing the name of our school district is so important to me. While I have a few reasons ranging in levels of importance, the overarching one is that the name is a painful reminder of racial, ethnic and religious hatred that have marred and continue to plague our country.

I have spoken at several school board meetings of the lens through which I look at this name change. As a first generation American, I learned early in my life of the struggle for freedom since my parents were escapees from the Holocaust and had to create a new life for themselves here. My family's history was based in the wholesale slaughter of a people because of its religion. America's history includes the wholesale enslavement and torture of a people based on the color of its skin.

Since Auschwitz was one of the Holocaust's centers of slaughter, it would be totally inappropriate for a name for a school district because of what it represents. The site itself was preserved by becoming a museum but it is also important to note the policy of denazification of Germany, which included painting over swastikas and discarding portraits of Hitler.

History is one thing and memorials another. The Dixie Schoolhouse Museum will represent the history. However, when a community names a building, a school or school system, it bestows honor and legitimacy. This makes the memorial every bit as much about values, status quo, and future as about remembrance. The name Dixie is so closely aligned with the Confederacy, slavery, and the subjugation of a people, that it is time for the change.

Please look at a name change as a value or a moral obligation, to be inclusive of all in our community. It is imperative that students confront slavery, racism, and exclusivity so they can be prepared for a future that supports more understanding of history and its complications.

As a realtor, I am fully aware of the direct correlation between a strong school district and the value of a home. The Dixie School District is what attracted my family to move here in the first place in 2011. We came from the peninsula, San Mateo specifically, where the public school in our neighborhood was broken. My first grade son needed help in reading, but he didn't qualify. The program offered at our neighborhood school was impacted with other first graders who were even worse off.

We discovered the Dixie School District, found a house within the boundaries, and made a quick decision to sell our house in San Mateo and buy in Marinwood. Although it was April, I was thankful to have found a school where my son could get extra help at school, paid the voluntary amount that is requested to fund the amazing CanDo! program, and began donating my time in the classroom. I became involved with many voluntary jobs within the school, such as Math Centers, the Dixie Diner, driving for field trips and helping at the book faire. I was so impressed with the many, many parents who all pitched in to make Dixie so strong. It was a big contrast to what I had left in San Mateo, which had very few volunteers and very little money to spend on effective art and music programs. (They couldn't even afford to keep the school library opened but a few hours per week.)

We have been here for almost eight years now, and I continue to pay the annual voluntary amount to CanDo! for my 7th grade daughter and now 9th grade son who is in the San Rafael School District at Terra Linda High. We are happy to help with the contribution, believing that our \$600 for Miller Creek and \$500 for Terra Linda is going to all the amazing programs listed on the flyers, talked about at the Back to School Night welcome speech, and in every email I receive requesting the contribution. This is what I give money for, not a school name change.

All of my friends living in our community are proud of Dixie and thankful to send their kids to exceptional schools. Parents are united in giving money, time, ideas, energy, and love to the Dixie School District, knowing that we all together make a huge difference. And my clients know this; they request to live in the Dixie School District when buying a home.

Our community needs the opportunity to vote on the petition to change Dixie's name. None of us are buying the reasons to change it. To spend the thousands of dollars to appease the outsiders and help them further their political goals is ridiculous. I did not give my thousands of dollars to be squandered by political activists, and never will. And neither did any of the families in our community.

Perhaps a history lesson should be taught to everyone to educate them on the origin of our great school district's name? The history of Dixie Dolls, Dixie brand cups, even Dixie State University is quite interesting, and was never intended to offend. Our church receptionist was also named Dixie, and she was not offensive in her beliefs or actions. Why would the Dixie School District be any different?

I also believe this decision is too vast for our Dixie School Board members to decide, especially due to the fact that two members have only been in their position for a couple of months. Let the community that gives their time, money and energy the chance to voice their opinions. Put it on the ballot in 2020.

Finally, it is disgusting to see how much time has been spent on this topic. To answer the rhetorical question, "Don't they have anything better to do?" Yes, they sure do. And they all need to get back to work and stop being distracted with political attacks on our community.

Dear Trustees of the Dixie School District,

I write to ask you to change the name of our school district, replacing the current name which is inextricably connected to America's history of slavery, segregation, and racism.

My name is [REDACTED] I am a homeowner (731 Del Ganado), taxpayer, and voter in the district. I also serve as Chaplain and Dean of Students at [REDACTED] Theological Seminary -- the [REDACTED] seminary in [REDACTED]

My husband and I moved to Marin County from Alabama 14 years ago. When we bought our home on Del Ganado, I was stunned when my husband told me the name of the school district -- Dixie. I asked him, "Do you think they know what it means?"

The word "Dixie" has a particular meaning connected to a particular history -- it is a history of slavery, confederacy, segregation, and resistance to civil rights. The word is connected to this stream of American history -- and the word carries this meaning throughout the country. I've heard folks say, "Well, we don't MEAN that here in Marin," some of them offering an alternative story that they say might connect to an indigenous woman from the 1800s. We all know -- and they know (look at the careful way they make this assertion) -- that there is not one bit of historical evidence to support this. The actual history of the name -- a dare to name it after the confederacy, attested in the schoolhouse history by descendants of the namer -- specifically attaches the name to the obvious history and meaning of the word.

But even more important than how the name historically came about is the present harm it is doing to our students in the district -- and particularly the harm to students and families of color. You have heard in public hearings (and I'm sure in these public comments) of the harm that students and parents experience every day when they go to a school whose name evokes white supremacy.

There may have been a time when you could have said, "Oh, we didn't know." But now you do. We are having a thorough conversation, and we are discussing plainly the meaning of this name, its connection to America's sorry history of racism, and the harm it is doing to our students. Now you know, now we know. The question now is, "What will you do?"

There's also rhetoric that this should be "decided by the voters" -- well, we all know that California law provides for school name changes to be decided by the voters through their elected representatives -- through you. By law, you are the way that this issue is decided by the voters -- we have elected you as trustees, this is your fiduciary, elected responsibility.

Right now, across the nation, public officials are being asked to remove symbols that evoke this history. This is your moment, and I hope you will do the right thing -- and find a new and better name -- one that better reflects the inclusive values of this community.

I know, as an elected official myself, that people volunteer for these positions with the best of intentions. Ms. Glickman should resign from the Dixie School District board of trustees.

She has violated her oath of office on multiple occasions.

1. She participated in both closed sessions and open session violations of the Brown Act as documented in the recent letters from two attorneys by two different district members/trustees.

She conspired with School Trustee Scholt and Trustee Hoescheiger to delay potential efforts to legally change the name through petition, and brought forward a limited vote of a non-qualified item to require a public vote on the issue in two years. defeated with great loss in killed and  
the loss of 700 prisoners. The bogus  
Confederacy is about to collapse.  
Stonewall Jackson has also been  
killed, and also the rebel Gen. Van  
Dorn.

Rejoicing at San Rafael—On the  
reception of the above war news, our  
citizens got up an impromptu cele-  
bration. The District Court being

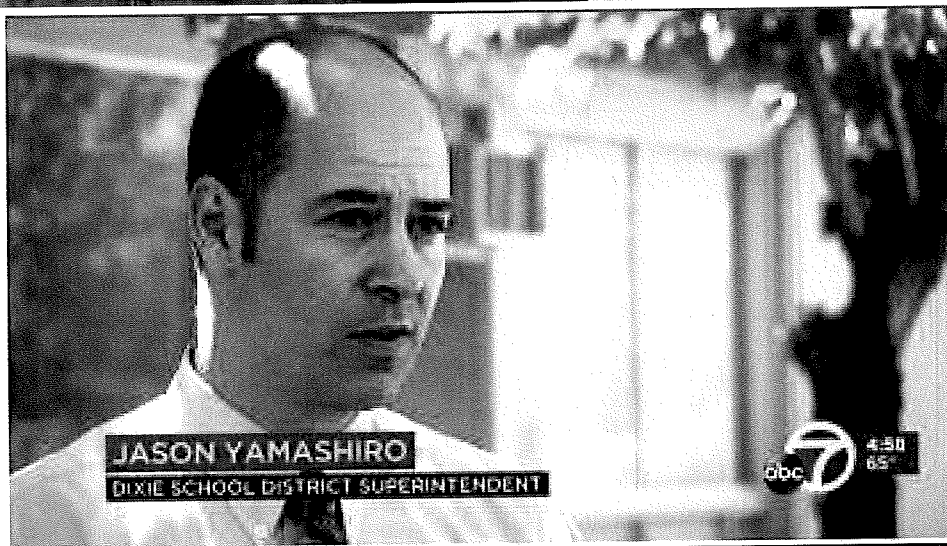

Superintendent Burke,

I am writing to you as a parent of a Dixie School District student.

Also, Charlie should resign from the Dixie School District board of trustees.

She has violated her oath of office on multiple occasions.

1. She participated in both closed session and open session violations of the Brown Act as documented in the recent letters from two attorneys by two different district members/trustees.

She conspired with former Trustee, Scott, and Trustee Hunsberger to delay potential efforts to legally change the name through petition, and brought forward a forced vote of a non-agreed item to require a public vote on the name in two years. This action does nothing to prevent petitions. She is literally wasting everyone's time.

2. She has blocked for no legitimate reason, Trustee Glickman from having multiple agenda items during her service as a VP.

3. She has held committee meetings in violation of the Brown Act to block the effort to change the name of the district. This is documented in two attorney letters to the district that have been posted to the district website.

4. She has publicly stated (in open session) she intends to block attempts to bring forward petition to change the district name. Petitioning is constitutionally protected.

5. She is incompetent. She directed staff to send an email chain to invite trustees to what would have been a meeting to discuss subject matter that also would have been a Brown Act violation.

Dear Board Members:

I am writing to share two thoughts regarding the proposed Dixie name change.

**1. Honor the Previous Decision for a Community Vote.**

The board has already decided to allow the local citizens to vote on this issue. I would urge the board to deny the recent petitions, so the vote can proceed.

**2. Even Without a Community Vote, There Is No Need to Change the Name – If a Problem Truly Exists, There Is a Better Solution.**

The analytical framework for this conversation has gotten jumbled in the noise. There are really two questions being asked: (A) Is there a problem with the current name? (B) If so, what is the best solution?

**A. In My View, The Name Is Not a Problem that Needs to Be Solved.**

Personally, I don't believe there's a problem with the current name. To me, it does not refer to the southern Confederacy and its associated evils. Our family has observed much inclusiveness and kindness at Dixie Elementary and Miller Creek. Our schools put a huge premium on inclusiveness and social/emotional learning.

However, if we assume that "Dixie" is a racist reference and/or makes enough neighbors feel angst that it should be deemed a problem, then what should be done?

**B. Even if the Name Is a Problem, a Name Change Is Not the Best Solution.**

Everyone has been assuming that changing the name is the only solution to a "name problem." That is not the case.


**I believe that the best solution is to keep the name, but also to institute a new, formal, ongoing, and continuous education program about the way that people of color have been marginalized for 400+ years in this country; the history in our country that has contributed to this marginalization; the day-to-day things that people can do right now to make our society better and more inclusive, etc.. We could start a social volunteer program where the students participate in an outreach day every year. On the first day of school, every year, one assembly topic could be the different interpretations of the Dixie name and the good/bad associated with those interpretations. We should continue our equity and inclusion committee, and our social-emotional learning programs. The Dixie name could be part of these trainings and conversations. Establishing this type of educational program is exactly within the School Board's purview.**

In a lot of ways, our Dixie conversation is like the clamor to remove southern monuments. What should society do? **If we sanitize the past, if we pretend it didn't happen, if we ignore history, then we're doomed to repeat it. Instead, let's shine a light on the good and the bad. Let's make it not just one teachable moment, but many, many teachable moments from Kindergarten through 8th grade.**

It may be helpful to watch this 60 Minutes segment (see link). A professor at the University of Richmond, Julian Hayter, gives his recommendation regarding the many Confederate monuments in Richmond, Virginia. He recommends keeping the monuments but also installing signs that accurately describe the history relating to those individuals. Professor Hayter happens to be black, so he can't be accused of racial insensitivity or white fragility. <https://www.cbsnews.com/news/60-minutes-the-history-and-future-of-confederate-monuments/>

For all these reasons, I respectfully request that the Board keep the Dixie name and deny the petitions that have been submitted. If the Board determines that the Dixie name is indeed a problem that needs to be solved, then I would urge the Board to institute the type of educational program described above instead of changing the name.
