Dear Mr. Honsberger,

There are three reasons we protest a name change for the District or the school at this time:

1. The petitions that were recently proffered, have one common fault: they say little or nothing about why they want to change the name or what is wrong with the existing name. These people knew they were going to do this six months ago, and now they are totally unprepared.
2. The word, "Dixie", is NOT a racist word, any more than the words, "chicory", "Gumbo", "Mint Julip", or "South Africa". It was and is a nickname for a large area of the United States, some of which tolerated slavery and some of which did not. For example, most men in Tennessee, including my great grandfather, fought for the North. It has been said this is a teachable moment; if some people, black or white, believe this word is racist, maybe now can be THEIR teachable moment. It is preposterous that they can submit Mary Dixie as a proposed name if Dixie is a racist word!
3. We loathe and despise the underhanded, deceitful and corrupt way this issue has been pushed.

We moved from Mill Valley to Terra Linda in 1976, and raised one son there. He went through Dixie, Vallecito, Miller Creek and TL, graduating in 2000. He and his wife and our two grandchildren (Vallecito) now live in our old house on Woodbine Drive.



Dear Trustees,

I do not live in the Dixie School District. I did live in the district for several years when I was a teenager, but by that time I was going to TLHS. I subbed for the district for 2-3 years about 10 years ago. I now live in Kentfield.

I suppose you all became trustees wanting to spend one night a month talking about budgets and facilities and staffing. Well, you can forget that. You're in a culture war now.

WHAT DOESN'T MATTER:

The expense doesn't matter. If it is wrong to keep the old name, then to complain about the expense is only a tacit admission that you're not really sure about what is right. And if the expense doesn't matter, then the offer of money to the district by some rich charity, on condition that you vote a certain way, is just about as crooked as it sounds.

How it looks doesn't matter, because that would mean you're more concerned with looking as if you're doing right, than doing right.

The possibility that some future board may change the name anyway doesn't matter, because they're not you. You're in charge right now.

WHAT DOES MATTER:

First, ask: What is this like? Has this happened before, to someone else?

Yes. The genesis for the current controversy was the 1994 campaign by the NAACP to remove the South Carolina state flag from the capitol building.

In that case, the Confederate battle flag had been used for forty years as the banner of the Ku Klux Klan, various white citizens' councils, segregationist mobs, and others opposed to civil rights. The flag stood for one thing: defiance of the moral decision rendered by the Civil War. According to those who flew it, slavery was a social blessing, white people were superior to black people, and segregation and the subjugation of black people was an appropriate model for society.

The modern civil rights movement arose in America after World War II, and of course this provoked an immediate reaction in the South. Between 1956 and 1962, Georgia, Alabama, and South Carolina all modified the designs of their state flags to feature the Confederate battle flag. The timing of these acts could mean only one thing: the endorsement of the malignant, hateful sentiments recited above by the respective state governments.

This is essentially what you're being accused of here. But none of the elements of that controversy exist in this case. The name "Dixie" has never conveyed the same virulent meaning as the battle flag; it was and still is innocuous in the great majority of its uses.

There has never been any evidence offered that any person, in the whole history of the Dixie School District, ever used the name or promoted the name, or admitted in public or in private, any understanding that the name was meant to endorse the idea that slavery was a social blessing, white people were superior to black people, or that segregation and the subjugation of black people was an appropriate model for society. This is truly a crime without a perpetrator.

But, in order to create one, the name change advocates say that James Miller was a racist, offering as proof only that there were many Democrats living in the area at that time; and that he was a slave-owner, offering no proof whatsoever. This demonstrates nothing but their willingness to stoop to any accusation, no matter how unsupported and scurrilous, to have their way.

The district's name is also a crime without a victim. There has never been a showing that any student, or any employee, or any other person either within or without the district, in the whole history of the Dixie School District, ever suffered any identifiable injury as a result of the name. In the pursuit of victims, the name change advocates have cited quasi-experts, professors with degrees in Literature who presume to lecture on the subject of Social Psychology, using terms like "micro-aggression" and "belongingness" to trick you into believing that you're not qualified to understand the supposed harm you're inflicting upon unnamed students.

You are told, endlessly, that various people have had their feelings hurt. All of these accusations are entirely subjective, reflecting only the fact that our society has evolved to the point where we no

longer distinguish between being injured, and being merely offended. It also has the effect of dividing society into classes; certain people among us now have the right to demand of everyone else that they be humored. The rest have to tip-toe around these people so as not to inadvertently cause offense. The inevitable result of this is a steadily growing population of Mary Todd Lincolns: they shriek, they point, they stamp their feet, they turn blue in the face, and everyone else scrambles to correct whatever condition upsets them.

So, if you're not guilty of using the name "Dixie", then what are you actually guilty of? Listen carefully to the name change advocates and you will hear: you are white, you are wealthy, and your community is not sufficiently diverse. Now ask yourselves: would you be any less guilty of these things were the school district to have a different name?

But before you answer, remember that you are not being accused of having done something, but rather having been something. And isn't this campaign on behalf of victims of similar accusations? Black people were enslaved not for what they had done, but for what they were. Since it is impossible for you to stop being white and wealthy, the least you should do right now is whatever your tormentors say. It is understandable that you would want to avoid trouble, and the easiest, most obvious way to avoid trouble is to surrender to whomever makes trouble. But don't be afraid. Abraham Lincoln once said that right makes might. Do not underestimate him. If, in your heart of hearts, you truly believe it is wrong to call your organization the Dixie School District, then of course you should vote to change the name. But if, believing it right, you acquiesce in calling it wrong, in a craven attempt to placate the yapping, silly, vicious, self-important hyenas who plague you...

Then shame on you.

Re: Change the Name of the Dixie School District

Members of the Board of Trustees,

Thank you for embarking upon this important process and for listening to the concerns of the public.

Although this is a high-energy, emotional subject, it is paramount that the Board of Directors demonstrate the leadership necessary and that they (you) make a well rationalized, thoughtful, but timely decision.

I was honored to speak at the Board meeting on January 15th and I hope to reiterate a few of the items that I believe are important to consider.

The majority of the discussion has been about the NEED to ***Change the Name***, and in some cases how to go about funding the costs associated with making the proposed change. I believe the cost issued was adequately addressed at the meeting.

As I mentioned at the Board Meeting, I have worked in the Fire Service here in Marin for over 30 years. I am a retired Fire Captain from the Marinwood Fire Department and the current Vice President of the Marin Professional Firefighters and Chair of the Political Action Committee. I am a graduate of Terra Linda High School, a homeowner/taxpayer/voter and have lived and worked within the boundaries of the Dixie School District since 1974.

My point that I attempted to make at the Board meeting was just this; the logistics involved with making the Change may seem daunting and that there are some who may be concerned about the loss of 'identity' associated with changing the name. It may be anecdotal, but I do have a lot of history and experience with this same issue and I firmly believe that it's a non-issue.

Much like the school districts, public safety is funded by taxpayer money. We have to pass Tax Measures, float Bonds, and elect our Boards in the public arena.

We also have been around a long time. The Sausalito Fire Department for example was founded in 1893 and operated continuously until 2012 at which time it ***Changed its Name*** to be part of the Southern Marin Fire District.

Those of us in the Fire service are very proud of our history. We have dedicated our lives to the service of the communities and put everything we have into them. Much like the dedicated teachers and staff within the School District.

But, in the name of progress, we have time and time again chosen to ***Change the Names*** of our agencies to meet the needs of the communities and to adapt to the new fiscal and operational realities. *At no time did these name changes get pushed out to the public for consideration; rather the Elected Officials who held office at the time recognized that it is exactly for times like these that they are chosen to make the tough decisions.*

Sausalito Fire, Alto-Richardson Fire, Tamalpias Fire, Fairfax Fire, San Anselmo Fire, Sleepy Hollow Fire, Ross Fire, Larkspur Fire, Corte Madera Fire, Twin Cities Police and the Terra Linda Fire Department have all faded into the rear view as time as passed.

They have not been forgotten, nor have they failed to provide the highest levels of service to the public and communities they represent, they simply are continuing their long traditions under a new moniker.

The students, teachers, and staff will go to bed one night under the banner of the Dixie School District and wake up the next morning under a new banner. It's just that simple.

Yes, you will need to change the names on the School Buses, just like we did to our Fire Engines and Police Cars. There will be new ID's and credentials, new stationary and envelopes, and big new fancy signs in front of the campuses just like there were at our Fire Stations. Everyone will take pictures and likely have a renewed sense of pride in whatever name is chosen. These things are all just the trappings of change and signs of progress. They should be embraced rather than used as yet another red herring to argue against the push to *Change the Name*.

I personally do not feel strongly about any of the proposed names that were submitted via petition. As a public entity I would caution against using the Skywalker name without having addressed the potential intellectual properties concerns via your legal counsel. If I had to choose one, I would like to support eh name "Miller Creek School District". Miller Creek itself, as well as its tributaries, runs throughout Lucas Valley, Marinwood and Terra Linda. All of the other elementary schools funnel their students into Miller Creek Middle School. Much like having a Dixie School within the Dixie School District, the same could be done with Miller Creek.

I do strongly believe that time is of the essence. I know you are aware of the three-ring circus that this has become. The best way for everyone to move forward is for the Board to make a decision, stand by your decision, and work on ensuring the plan will be successful. Ideally the changes could be made over the summer, and when the kids return to school in the Fall they will be helping to usher in a new era and they will be writing new chapter in the history of the school district.

I know it may not feel like it at times, but you are fortunate to be in a position where you can make a real difference in the lives of the community and can positively effect the reputation of the school district and neighborhood.

**READ THIS LETTER IF YOU WANT TO KNOW HOW THE DIXIE
COMMUNITY FEELS ABOUT THE NAME CHANGE ISSUE**

The Board has listened patiently for months to comments regarding a proposed name change for the District. Out of respect for the Board's time, and to avoid superfluous participation in another media circus, WeAreDixie will limit its participation in the public comment segment of the February 12th School Board meeting. However, in order to help guide your decision, the following compilation of comments reflect the sense of a strong majority of the Dixie community.

1. Limit comments on this subject at the February 12th meeting to one minute. It is unlikely you will hear much of anything new.
2. We ask the Board to respect the decision that the previous Board has already made. Put this issue to a vote of the community.
3. The Board should listen to the residents of the Dixie community. Not to people from outside the District and certainly not to late opining politicians who only spoke up when they thought it was safe to do so.
4. The Dixie District has always been an open, welcoming community, not what it is being depicted to be now.
5. Our children are being cruelly indoctrinated to feel ashamed of their schools by CTN advocates who are equating our Dixie with the Confederacy of long ago.

6. Use logic and fact, not emotion to make your decision. That is what we would want our children to do when facing important issues in their lives.

7. The Board has been forced to devote its time to this distraction, rather than its principal mission of educating our children. Do not reward the CTN advocates by caving to their pressure and bullying.

8. Consider the irony of demanding that the District change its name by the African-Americans who have appeared at Board meetings. The vast majority of African-Americans carry a name that was acquired by their ancestors under very disturbing circumstances hundreds of years ago. But it is their name now and should be carried proudly, just as we should all be proud of the Dixie name and what it represents today.

9. The Dixie District never was, and is not now, a reflection of the era of slavery and Jim Crow that existed a long time ago and very far away.

10 There are 8,000 African-American women in America today named Dixie. Should they be asked to change their name? Should every town, company, product, and music genre that has the name Dixie be asked to change their names? Should everything named Dixie be boycotted?

11. If education is the principal responsibility of the School District, can we just stop this wasteful effort and let the Board get back to its principal mission?

12. Wouldn't the time, energy and money being spent on the name change initiative be better spent on improving the prospects of our children? Marin Community Foundation should donate money for scholarships, not for this wasteful project.

13. Does anyone really think that changing the name of Dixie will do anything to improve the lives and future of our children?

14. The change the name effort is being led by a small group of mostly out of District activists and a Board member with political ambitions. A name change will stroke their egos. No one else will benefit.

15. We are proud of our School District and the quality education that Dixie signifies. Thousands of children who have gotten their primary education in the District feel the same way. Don't change the name.

16. Put the issue to an advisory vote of the District residents. Let democracy work.

17. Activists have the time and money to pursue their latest cause. Parents are busy working and raising their children. Do not be swayed by this professionally orchestrated, well-funded campaign.

18. We have children in our District living in poverty, requiring subsidized lunches and living in stressful environments at home. Let's put our energy into helping them, not useless name change initiatives.

19. Got time on your hands? Volunteer to work in the classrooms.

20. A peaceful community has been rocked by this name change campaign. Neighbors quarrelling. Friendships ending. Accusations of racism. Threats of law suits. Disgusting profanity being hurled about. And to accomplish what?

21. It is really quite depressing that the School Board is giving so much time to a small group of out of District activists.

22. It is too late to convene community forums. The well has been poisoned by the tactics used by those who profess to care about our children. Put it to a vote and be done with it. WeAreDixie will respect the wishes of the community. We suspect the CTN advocates will not.

23. In an odd way I find the name change initiative quite encouraging. What it tells me is that there are so few issues of real racism in our

community that the professional social justice warriors have pretty much run out of causes to pursue. In desperation, they have latched on to the Dixie name change to regain purpose in their lives.

24. Not a single member of this Board ran on a platform to change the Dixie name. In fact, Marnie Glickman deceived the voters by denying that a name change was her priority. If you run again, clearly state your position regarding a name change. If a majority of the Board is elected after stating they want to change the name; then go ahead, change it.

25. Why are you allowing people who do not live in the Dixie School District take up your valuable time? If people started showing up from say, Walnut Creek, Utah or South Carolina, would you listen to them?

26. The District and County are already being subjected to ridicule. Why are people in our County spending time on this trivial issue when there are so many legitimate issues that need attention? Housing, traffic, poverty, homelessness, educational challenges, to name a few.

27. Do the two new members of the Board really think they are already in a position and know enough to make such an important decision?

28. I am confused. This is a 150 year old, outstanding school district. How is reaching out to national media before initiating a discussion among community residents in the best interest of our kids? Why are School Board meeting being videotaped? Why are people giving interviews to the press? Who is this name change campaign really going to benefit?

29. One thousand three hundred twenty five (1,325) people have already signed a petition to retain the Dixie District name. These are people with a close affiliation to the District whose children are now attending a Dixie School or who have attended in the past. These

signatures were obtained by working parents, not public relations professionals and out of District activists.

30. Still don't know what to do? Take some advice from Abraham Lincoln. **President Lincoln** was desperate to unite the country once the war ended "with malice toward none, with charity for all". As the celebration in Washington was reaching a crescendo, with bands marching down the streets, he **made a simple request**. "**Play Dixie**. It is our song now".

Dear Dixie School Board Trustees,

First we would like to welcome Megan Hutchinson and Brooks Nguyen. We are looking forward to working with you and the veteran board members in the future. The reason for writing is to come forward as a caring and diverse group of parents and staff, for changing the name of the Dixie School District.

As a group, many of us have been quietly following the name change debate, while others have been more vocal. We feel the need to come forward now as we have come to a critical juncture. We are active members on the Equity, Diversity, and Inclusion Committee which exists in the interest of promoting a more equitable and inclusive culture in our schools. Some of us have been personally affected by racism in our community. The We Are Dixie website claims racism does not exist here. We can tell you that is false. Simply ignoring racism won't make it disappear and the ongoing attempt to negate or minimize our experience is hurtful. Because a thing is not considered offensive by the majority, does not make it inoffensive. The word Dixie's origins are rooted in the confederacy. Regardless of how the Dixie School District got its name, the word Dixie cannot be extricated from its historical meaning.

Not actively working to dismantle the racism that exists right here in our community only serves to marginalize and alienate a portion of our community. If all voices are not acknowledged, how does this benefit us? One of the board goals published on the district website is "academic success for all students." We would argue that social and emotional success leads to academic success. Continuing on the path of inaction is saying to some that they are less than their counterparts.

Changing the name of the school district is not going to fix the problems of racism, or of gender, or socio-economic inequalities but it will signal that the district is willing to take on the tough issues that affect our marginalized and least represented students and families. The district has taken some steps toward these issues through staff training and looking critically at the curriculum choices but more could be done. We are asking you to consider the alternate names that were presented to you by petition. Please work in the interest of equity and inclusion for all.

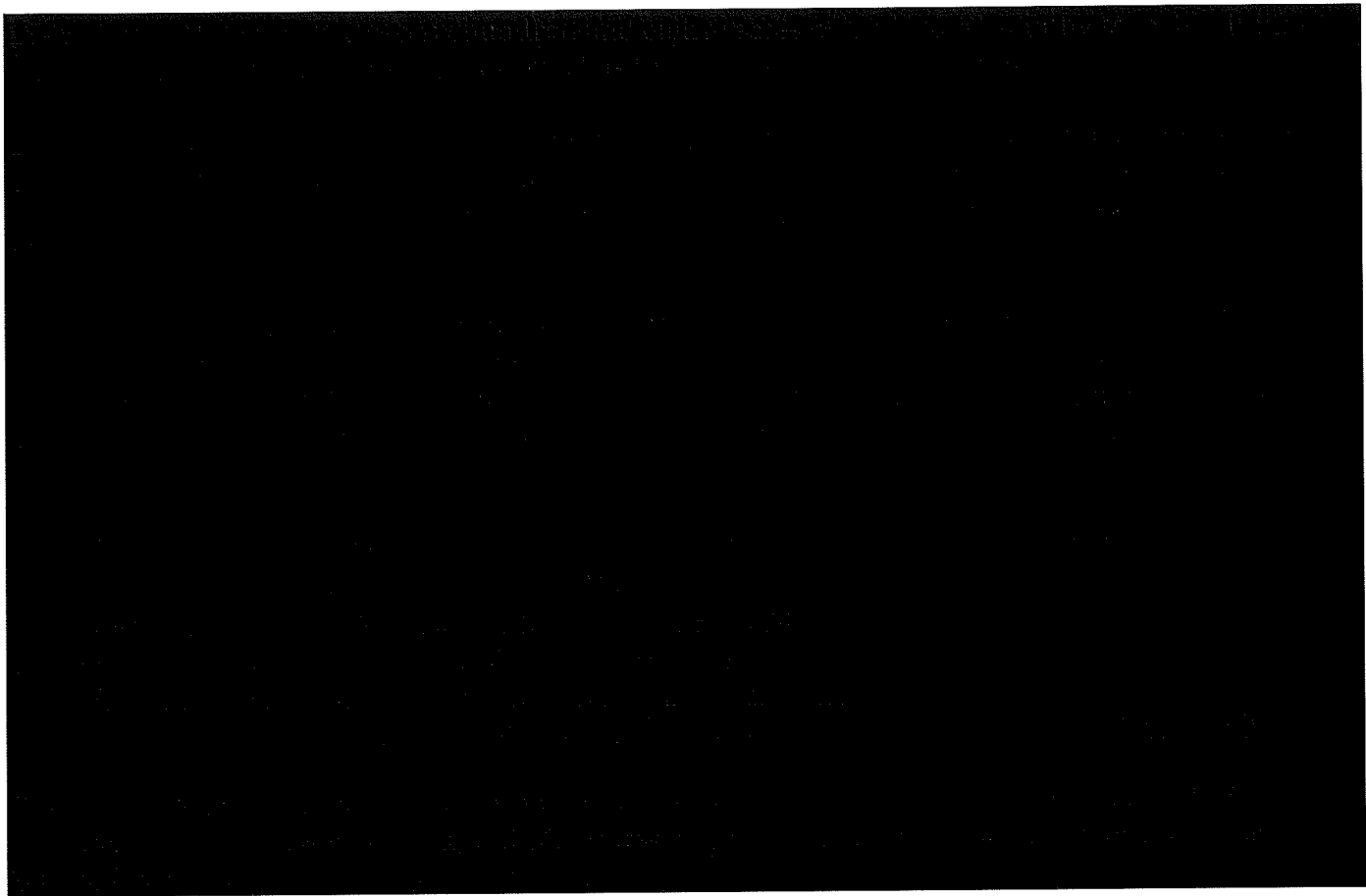

July 11, 1863: The raid of Lee into
Pennsylvania has resulted in one of
the most desperate battles of the
war. His army of 125,000 men, ve-
teran troops—the flower of the bogus
Confederacy, has been completely
whipped and overthrown. His im-
mense trains of wagons for the trans-
portation of plunder from the Yan-
kees, with his artillery, and mun-
itions of war have been captured or
destroyed. The Federal loss in killed
and wounded is estimated at 12,000
—the loss of the rebels at 30,000 to
50,000 in killed, wounded and captur-
ed. With this good news comes the
news of the capture of Vicksburg by
General Grant, when Gen. Pembro-
ton surrendered the Sebastopol of the
Confederacy. On the same day the
rebel General Price with 18,000 troops
attacked Gen. Prentiss, entrenched
with 5,000 Union troops. Price was
defeated with great loss in killed and
the loss of 700 prisoners. The bogus
Confederacy is about to collapse.
Stonewall Jackson has also been
killed, and also the rebel Gen. Van
Dorn.

Rejoicing at San Rafael—On the
reception of the above war news, our
citizens got up an impromptu cele-
bration. The District Court being
in session, the county was well re-
presented. Governor Chellis, the of-
ficers and guards of San Quentin
joined us and kindly brought over
some big guns, which made the hills
echo. After the firing the people
were entertained with speeches brim-

"ONE DAY would be lovely and the following would be coupled with misery and sorrow, and the undertaking was really heroic — sufficient to immortalize those who succeeded in its accomplishment.

"After weeks of drudgery and suffering, not to mention the fear of attack and possible annihilation by Indians, the monotony wore off as the snow-capped Rocky Mountains, in their solemn grandeur, arose in front of us. For a few days the change kindled within the human breast a hope that from the summit of the highest pass



tain we would soon procure a glimpse of the land of sunshine, fruit and flowers, which we were soon to possess."

But still a long journey lay ahead of the travelers with the ordeal in the Sierra described by Stone, Bancroft and others.

"And there were times," related William J. Miller, "when the hide of the buffalo or the riata was used to make soup for our hungry and fatigued wanderers."

WILLIAM J. Miller was also the source of information about happier days, after the Irish Millers had settled in Marin County, learned the Spanish language and quickly adapted themselves to the Spanish-fla-

Of Miller Hall, he said: "It was the mecca of the young aristocrats of the county and many delightful functions were held there. In the large fireplace in the spacious parlor the coffee pot always swung on the crane and delicious refreshments were served by the young folk."

Other early-day Marinites have left their recollections of Miller Hall hospitality and spoke of the beauty of its gardens, and of the fountain that "sprayed and played" in the circular pool at the entrance driveway.

IN A DIFFERENT light, two of the Miller girls had stood up as godmothers to two Indian babies. When their mother died, the father brought the Indian children in baskets to Miller Hall and presented them to their godmothers. The Millers raised the Indian youngsters as part of their household.

Sorrow invaded Miller Hall when the James Millers' daughter Julia died May 30, 1880. Mrs. Miller, weakened by grief followed her on Dec. 26, 1882 and in October of 1888, a son, Martin, was killed in a railroad accident.

Finally, on Nov. 25, 1890, the long trail came to an end for intrepid pioneer James Miller after a prolonged illness.

THE FUNERAL services were held across the road from his beloved Miller Hall at St. Vincent's orphanage, an institution in which James Miller had always taken a keen interest and to which he had contributed lavishly, so that he was sometimes called "the foster father of St. Vincent's."

Unmarried daughters of the James Millers remained at Miller Hall for a time, continuing the hospitable traditions of their parents. Kate Miller married John Keys while another daughter became Mrs. Joseph Kirk.

And the off-spring of James and Mary Murphy left their own stamps upon Marin County. Many reared large families.

Lodge and converted into a clubhouse. It was sold in 1961 to Bank of Marin, which razed it to make room for its present bank building on the site.

Marin County Courthouse was built in downtown San Rafael in 1872-73, and a real estate dealer whose transactions included the sale of the Patrick King Ranch, near Larkspur, to the American Land and Trust Co. for \$26,000.

William J. Miller bought the northeast corner of Fifth Avenue and B Street in 1887 and built a two-story house there. In later years he sold that property and moved a short distance east to a two-story Victorian residence. The earlier Miller home was bought by the socially prominent Fred Gibsons. Gibson, in turn, later sold the showplace to San Rafael Elks Lodge No. 1108 which converted the dwelling into a clubhouse and used it for years before selling the property in 1963 to the Bank of Marin which razed the clubhouse and constructed a modern new bank building.

WILLIAM J. Miller died in March of 1916. His obituary in the San Rafael Independent listed as his survivors his widow Isabella, sons George and William A., his brother Bernard T. Miller, and his sisters Therese Miller and Mrs. Joseph Kirk.

In Marin, many place names are attributed to the Miwoks, from Tamales to possibly Bolinas. Other commonly used titles are even familiar as they pop up in the names of area schools — we're looking at you, St. Francis Drake. But other monikers' roots are a bit more elusive. Here are some local schools and information about their namesakes.

- A. L. Kent Middle School is named after Albert Emmett Kent, who moved to Marin County in 1871 and bought the land that would later become the town of Kentfield.

- The Date School District does not have Confederate roots; it's named after Mary Date, a descendant of the Miwok Indian tribe who used to live in Vallejo, California.

- Edna Maguire School in Mill Valley is so called in tribute to the educator and historian who was born in 1888 and inspired students with tales of California's gold country.

- James B. Davidson was the first superintendent of the San Rafael City Schools district, which was established 155 years ago. The middle school there is called Davidson to honor him.

- San Rafael's Mary E. Sáenz Elementary School commemorates the woman who was an advocate for quality education in the Date school district.

- Neil Cummins was a principal at the Parkspur-Corte Madera School District; the elementary school there was named after him.

- Vallejo Elementary School in San Rafael gets its designation because of its location; it's nestled in a valley, or *vallejo* in Spanish.

- Wade Thomas was a principal of Moss School in San Anselmo and the school district's supervisor starting in 1928. He died unexpectedly while the school was being retrofitted and it was rechristened in his memory.

None of the Board Members, including Ms. Glickman, should incur personal liability for Brown Act violations. In addition, given the strong public sentiment regarding the Dixie name change, this matter could end up in litigation and such violations would undoubtedly be revealed. I litigate regularly with municipalities and sometimes these Brown Act issues come into play. When they do, I typically make a public records request and seek all documents and emails regarding the matter. The attached email is one that would cause great embarrassment to the Members of the Board.

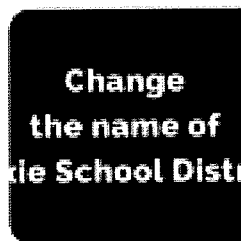

I am writing to you as a parent of a Dixie School District student.

Alisa Charlin should resign from the Dixie School District board of trustees.

She has violated her oath of office on multiple occasions.

1. She participated in both closed session and open session violations of the Brown Act as documented in the recent letters from two attorneys by two different district members/trustees.

She conspired with former Trustee Schott and Trustee Hensberger to delay potential efforts to legally change the name through petition, and brought forward a forced vote of a non-agendized item to require a public vote on the issue in two years. This action does nothing to prevent petitions. She is literally wasting everyone's time.

2. She has blocked for no legitimate reason, Trustee Glickman from having multiple agenda items during her service as a VP.

Please change the name of the school district. Named in 1863 by James Miller on a dare by his neighbors who were building the schoolhouse ^{1,2}, it is time to let go of "Dixie". His intent is lost in history and is argued today. The effect however remains. "Dixie" cannot be dressed up for me. I will share why below.

A new name should be one that the community can say with pride "I go to school in the xxx" district." I hope that you vote to change the name to Live Oak Valley Elementary School District or LOVE School District for short. I imagine the first people those many years ago coming over the hills and spying our valley. Seeing the abundant live oaks with a bounty of acorns for food. Streams full of fish. The feeling they must have felt was akin to Love. The words they used to name the place may be gone by that feeling remains. Love is what we came here for. Love is the opening door. Please vote for LOVE. Live Oak Valley Elementary School District.

Why "Dixie" can't be dressed up and should be changed. While the origination of the name for the Dixie School District is rooted in honoring the antebellum south, that is not the only reason "Dixie" is an offensive name to me and many people of color.

The root of my trepidation in 1989 about delivering my six year old son to a school named Dixie began when I was young.

When I was young we watched TV on one of three channels at night. I have a strong memory of all three channels telling the story of a young black boy, Emmett Till, being beaten and killed when he visited Dixie. His crime- he looked a white woman in the eye. I vividly remember the image of his badly beaten body in my mother's JET magazine. Killed in Dixie.

I was 8.

For the next 10 years all manner of abuse was heaped on people that looked like me by people in Dixie. In Sacramento, California I was an interested observer.

I watched as people all over Dixie resisted Brown V Education by any means possible. It played out on those three channels. Beatings, Riots, School Closings. I watched as people that looked like me were denied lunch rooms, clean toilets, clean water fountains throughout Dixie.

I listened as Senator James Eastland told the world that segregation would never end in Dixie. Followed by a host of Governors standing in school house entrances throughout Dixie proclaiming "We are Dixie" and vowing that people who looked like me would never enter their schools.

I watched as people who looked like me were dragged out of lunch counters just for sitting on a stool in Dixie. Throughout Dixie the inevitable change was resisted and fought by those that wanted to keep Dixie,

Dixie.

There are many more images of Dixie formed those years. Dixie was not a place I ever wanted to be.

That is what drives me to change this name. No person should feel any trepidation about delivering their child to school because of a name.

No teacher should ever feel any trepidation about working for a school district because of a name. Has that happened here? A question to ask is why has there been only one african american teacher in the history of the school district? Has a form of external restrictive covenants (the name of the "district) put trepidation in the mind of the potential applicant? By the way, Branson has three African American teachers.

A name change is the right thing to do. Now is the right time to change it.

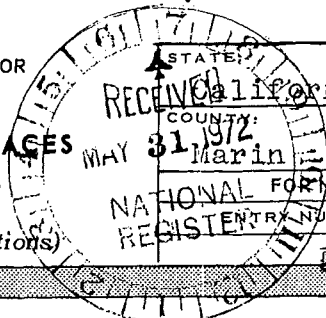

<p>It should first be noted that in order to save the Dixie Schoolhouse from demolition, it had to be moved from its original site. Moving the schoolhouse was the only alternative to destruction.</p> <p>The Dixie Schoolhouse is a rectangular one-story building, approximately 25' by 40' with very high ceiling space. It contains simple classical details. Originally the school building was located on a deck which projected approximately five feet from the building. Examination of the 1895 photo reveals this deck. Future plans call for restoration of this deck. The original foundation has been replaced by a concrete foundation on the school's new site on Miller Creek School property. (This new site is approximately one-quarter mile from the original site, and is part of the original James Miller land holdings).</p> <p>Deterioration of original materials is minimal, although because of continuous and various use, the interior of the school building has experienced minor alteration. More correctly, it has experienced "addition." The room was partitioned, and a lower ceiling added in the 1950's. However this fixtures were not permanent and have been removed with no substantial impairment of the interior. The process of restoration has revealed the original wooden floor (it had been covered with linoleum), and blackboards. Interior restoration is now in progress.</p> <p>The schoolhouse has a symmetrical facade with windows (four over four lights, double-hung wooden sashes) flanking the entrance. This entrance is a double-door with a single light transom above. The building has three bays across the principal facade, and two bays on the side facades. This is original to the building.</p> <p>Details include Italianate bracketed roof and window cornices, and a simple dentil course below the roof. The building has a hipped roof with a central pediment above the entrance on the principal facade. The pediment contains a circular applique ornamentation. These details are original to the building.</p> <p>Originally the school was painted white with details and trim in a darker color. An earlier and much smaller rectangular school-building (1864) is now attached to the rear of the main schoolbuilding. This building has served as an annex since 1868-69. It has no decorative details. In the 19th century, the school was surrounded by a white picket fence, and the main schoolbuilding had interior louvred shutters which will eventually be replaced.</p> <p>During the 19th century, the roof, now asphalt, had redwood shingles; the Foundation plans to replace the present roof with wooden shingles.</p>

STATEMENT OF SIGNIFICANCE			
<p>The Dixie Schoolhouse in Marinwood (San Rafael), California is both historically and architecturally significant in relationship to early California. Not only does it provide a valuable link to the well-known James Miller family, but it is Marin County's last remaining mid-Victorian one-room schoolhouse which is substantially unaltered, and intended for viable, contemporary public use as an educational museum and meeting place. The Office of the Marin County Superintendent of Schools has verified this fact. The other schoolhouses of this era have either been converted to private residences or demolished.</p> <p>James Miller and his family pioneered the overland trail to California in 1844 and, once here, contributed substantially to the development and growth of California.¹ Munro-Frazer and H.H. Bancroft both describe the role James Miller played in the famous Murphy-Stevens party of 1844 which, with the aid of the Indian guide, Truckee, opened the wagon route into California. Both they, and the more contemporary authors, Irving Stone and George Stewart, attribute the success to the combined courage and coolheadedness of Martin Murphy, James Miller and Elisha Stevens, and this history-making group has variously been called the Murphy party, the Murphy-Miller party, and the Stevens party.</p> <p>Once safely into California, with the winter past, Miller brought his family to Marin in 1845. There, Timothy (Don Timoteo) Murphy, delighted to learn that he and Miller were both born near Wexford, Ireland, granted Miller 680 acres of the Las Gallinas Ranch where the Millers had camped on their first night in Marin. This land was part of the famous Mexican land grant which Murphy had received in 1854 from the Mexican government.</p> <p>In 1849, Miller, long-interested in fostering education, built the first schoolhouse in San Rafael. In 1855 he contributed funds and labor to the building of St. Vincent's School (California Historical Landmark #630). The School lay directly across from his own homesite, Miller Hall.</p> <p>Regarded by many as the "foster-father of St. Vincent's"² his interest in education continued. had been privately tutored, in 1862 when his youngest son, Bernard, was six, Miller donated $3/4$ of an acre for the Dixie School which was to be built near the Las Gallinas home ranch, so that Bernard would have a school to attend. On November 3, 1863, the Board of Supervisors formally established the "Dixie Public School District", making Dixie one of the earliest districts to be established in Marin. The original Dixie Schoolhouse, which later became an annex and library to the larger and newer schoolhouse, was built in 1864. This fact is confirmed both by Bernard Hoffman's notes, and the Superintendent of Schools Report in 1899. Mr. Hoffman, raised by the Miller family, attended Dixie in the 1870's, and later served as a trustee of the district for 50 years. His notes, commenting on a 1953 newspaper article on the Dixie Schoolhouse, state that the "present annex to the main building was built in 1864. I have seen '1864' printed on its side. The large building was built later."

Mr. Hoffman's memory served him well. An 1899 Report of the Superintendent of Schools confirms this date. It also records that the "Dixie District is richest in proportion to population in the County. It joins San Rafael on the north and includes in its territory the St. Vincent's Orphanage where there are about 500 children. On account of these children the district secures large State apportionments. After paying all expenses large sums accumulate which are apportioned to the other county districts. The District was organized Nov. 3, 1863, and a house was built and school opened in March, 1864."⁵

Mrs. Frances Miller Leitz, daughter of Bernard Miller for whom the school was built, and granddaughter of James Miller, is still living. She has stated that her grandfather not only donated the land, but helped haul redwood from the Nicasio Mills for construction of both school buildings. A comparison of the later schoolbuilding to photos and drawings of Miller Hall shows a striking similarity in design principles, which suggests that the same architect was responsible for both. Mrs. Leitz also uncovered the origin of the school's name when she stated that her grandfather, not being a man to turn down a challenge named the building on a dare. Marin County, in 1864, was hotly pro-Northern, and the fact that several "gentlemen" from the South helped construct the first schoolhouse prompted someone to dare James Miller to name the school "Dixie." He did. Thus Dixie opened in March of 1864.

The construction date of the later building has generally been attributed to 1869, but, until recently, no documentary proof had been uncovered. However, recent research at the State Archives has provided substantial evidence that 1868-69 was the construction date for the Dixie Schoolhouse which bears such striking resemblance to Miller Hall. Starting in 1865, all County Superintendents of Schools were required to turn in an "Annual Report of the Condition of Common Schools." This

report, now in the Archives, includes teachers' names, salaries paid, student attendance, money received, and expenditures itemized for the schoolyear. Thus we have a fairly detailed record of what occurred in each school district for the year reported.

Until the schoolyear, 1868-69, Dixie school property, which included schoolhouse and equipment, was consistently valued at \$300. In 1868-69, the total "valuation of property" suddenly jumped to \$1100, and for the first time the evaluation included a "library." It seems the first little schoolhouse now served another purpose--as library annex to the new building. A note in the Marin County Journal, Thursday May 29, 1873 confirms the use of the annex as a library. "The Dixie School, under Miss Giffin, has sixteen pupils enrolled with a good average attendance. They have a good school room with library attached which contains a very choice selection of works. It is considered a model school in all its appointments."

Finally, on January 9, 1874, James Miller deeded the 3/4 acre site to the Dixie School District on the sole condition that the property be used exclusively for public school purposes.

It should be noted that research continues. The Dixie Schoolhouse Foundation, responsible for the restoration and interpretation of the schoolhouse, has just recently come in contact with James Miller's two oldest surviving descendants, and many of the family documents, deeds, papers and photographs have yet to be analyzed. Frances Miller Leitz, James Miller's granddaughter, taught at the Dixie Schoolhouse, and will be of tremendous help in providing the Foundation with an accurate description of the interior of the schoolroom at the turn of the century, as well as daily school life, and life with the Millers.

The whole purpose in back of this restoration project is to return something of historical and architectural significance to current community use. Dixie is the only schoolhouse of mid-Victorian architecture which is still devoted to public use. Once restored and refurnished, it will become a multiple-use museum, serving as a reminder of James Miller's contribution to early Marin history, and as a place where pupils can visit on field trips, and gather for special classes, as well as a place where community groups may meet for various purposes

Assessment of Name History: Dixie School District, San Rafael, California

After reviewing the historical documents compiled by Change The Name (www.changethename.net) advocates, as well as a number of supplementary sources, it is my conclusion that the organization's account and characterization of the historical origins of the Dixie School District's name are accurate. Following are my brief descriptions and assessment of key documents, as well as two interpretative elaborations about political party membership and local perceptions of partisan speech in the 1860s.

On November 28, 1863, during the height of the Civil War, alongside local real estate transactions, the *Marin County Tocsin* formally recorded the school district's establishment, location, and name "Dixie"—decisions made under the aegis of T. J. Ables (Superintendent of Schools), and JAS Dixon, D. Olds, and J. W. Buffington (Board of Supervisors).¹ The claim that the name "Dixie" was understood by local community members to signal support for the Confederacy in the early 1860s is corroborated by several reliable period sources. When the *Marin County Tocsin* (a paper also published under the name *Marin County Journal*) reprinted the anthem "Dixie" on its front page on April 27, 1861, the editors made overt reference to the fact that the song was the Confederacy's equivalent to "Yankee Doodle." This is strong evidence that the song "Dixie" was understood by Marin County residents to endorse the Confederacy and its secession plan. When, two years later, the staff of the *Red Bluff Independent* learned of the Marin School District's choice to name itself Dixie, their editors' disgust was palpable:

It is supposed, by the ominous name, that the young ideals are here to be "trained how to shoot" you. The most surprising thing about this name is, that the inhabitants of such a district should ever desire the establishment of such a radical thing as a school. Probably the effect of association with civilized people in this State.²

The first elaboration I want to offer to Change The Name's historical account concerns party affiliation and school district naming; simply offering local Democratic versus Republican party membership in the 1860s does not adequately capture the ideological diversity of the community. That diversity is relevant in assessing the meaning and reception of the school district's name. Many Democrats in both the American South and the North opposed secession, as the following January 4, 1861 letter from G. Mason Graham to William Tecumseh Sherman illustrates:

I feel as confident as I possibly can of any event not yet transpired, that an ordinance of secession will be rushed through the convention with breathless haste. The tone of the Louisiana *Democrat* ever since the presidential election has satisfied me of that—its last issue confirms it. Less than four weeks ago I proclaimed from the steps of the post-office, to an unusually large crowd awaiting the opening of the mail, that 'I stood by the Union, that secession was treason,' and no man in the crowd opened his mouth affirmatively or

negatively, although I saw men there—lifelong Democrats, too—who, I knew, felt and thought as I did about it.³

Graham's letter suggests that people were carefully reading the tone of newspapers, as well as their explicit content; tone was important because many people were remaining publicly silent about their views on the secession issue. Graham understood explicitly partisan political speech to be a bold (even perilous) choice in many localities; the period content of California newspapers (particularly in and around Marin County) suggest that many editors agreed with this assessment.

Using the term "Dixie" in the name of a public institution in early 1860s America was not a simple statement of support for the Democratic party; it was reasonably and broadly construed to be an endorsement of secession. In his memoirs, Sherman was more generous than the Red Bluff editors in characterizing the partisan political speech of cadets (sometimes termed "seminarians") at the Louisiana military academy where he taught after leaving California, in November of 1860:

The election of Mr. Lincoln fell upon us all like a clap of thunder. People saw and felt that the South had threatened so long that, if she quietly submitted, the question of slavery in the Territories was at an end forever....At our seminary the order of exercises went along with the regularity of the seasons. Once a week, I had the older cadets to practice reading, reciting, and elocution, and noticed that their selections were from Calhoun, Yancey, and other Southern speakers, all treating the defense of their slaves and their home institutions as the very highest duty of the patriot. Among boys this was to be expected; and among the members of our board, though most of them declaimed against politicians generally, and especially abolitionists, as pests, yet there was a growing feeling that danger was in the wind.⁴

In Sherman's view, such vocal demonstrations of Confederate loyalty were understandable in 1860 only because of the proximate "shock" of the election, and the fact the speakers were immature "boys." He clearly would have considered the same kind of speech from seasoned politicians, or other community leaders, as both uncouth and treasonous—as did the editors of the Red Bluff newspaper, who thought the Marin School District's choice of name was outrageous enough to merit comment and condemnation.⁵

The second elaboration I would like to offer concerns more local public perceptions of politically partisan speech. In the same issue of the *Marin County Tocsin* that covered the aftermath of the 1861 political duel fought in San Rafael between politicians Charles W. Piercy and Daniel Showalter—a fatal conflict resulting what they deemed irreconcilable differences related to the secession question—was a re-printed editorial attributed to another publication (the *Tribune*):

An earnest secessionist, whether of the North or of the South, may be very blind, but he is not necessarily a bad man. And, wrong-headed as we may deem him, we insist on his perfect right to his own opinion, and to pursue a peaceable course of action in open consistency therewith....He must refrain from shooting if he has any decided objection to being shot, and restrict himself to *speaking* daggers if he prefer that the friends of the Union should not use them.⁶

In an era, and locality, in which political differences could (and did) cause at least one fight to the death, I believe that the Marin County community accepted the "speaking dagger" of the Dixie School District name because, in context, rhetorical violence seemed preferable to physical

confrontation. The newspaper made its position condemning physical violence clear, pointing out (ironically) the dubious distinction such incidents conferred on the community: "another 'affair of honor' is on the tapis—arising out of the Shoawalter-Piercy duel. Of course Marin will have the honor of being the place where they will settle their difficulties."⁷ On the front page of that same issue of the paper (which included war news about troop movements, accounts of government seizure of Confederate ships, and news about the real and perceived loyalties of African Americans in New Orleans and Native American tribes), the editors printed a long, patriotic poem about the American flag, attributed to a fourteen year old author, Mary Jane Cunningham.

Both the Democratic and Republican parties continued to hold local meetings (as indicated by 1860s announcements in the *Marin County Tocsin*), and members of both parties continued to participate actively in California civic life. The extant historical sources suggest that, in 1860 and 1861, leaders in Marin County took and maintained the position that a wide range of political speech—even virulent speech—was the best option for the community, because it could help preserve the peace.⁸ The 1863 choice of the highly politicized (and, for the majority of Californians, likely offensive) name "Dixie" for the newly- formed school district suggests that the community maintained that position throughout the Civil War years.⁹

Dear Trustees,

In the name of kindness, please change the name of our school district. It does not matter where "Dixie" came from, only that it is offensive and even hurtful to many. Keeping "Dixie" in any form would also undercut national efforts to remove public symbols of the Confederacy, and of the slavery and Jim Crow for which it has always stood.

The origin of the name is irrelevant to the need for name change

We cannot erase history, nor should we try to. But whatever our curiosity about how our school district came by its name, the proper forum for the explanation is the site of the Dixie Schoolhouse, immutably listed on the National Register of Historic Places and now sitting on the front lawn of Miller Creek Middle School.

The need for a name change comes from the fact that, for most people, "Dixie" evokes racism. It may be something of a challenge to help those for whom "Dixie" is merely the benign name of their or their children's school district, people who are not racist themselves and have trouble understanding how to square their benign perception of the name with what most people hear. However, we can hope that they will learn to empathize with those, especially people of color, who find the name offensive and hurtful. It would be unkind to keep the name "Dixie." We should not be teaching our children unkindness.

We should join national efforts to remove public symbols of the Confederacy

We should also join in national efforts to remove all public symbols of the Confederacy, notably by removing Confederate monuments, names and flags from public spaces. See, for example, the following:

As a mother of two children who attend school in the Dixie School District I am offended that we are having this debate about whether or not to change the Dixie name. I do not believe as a white woman I am in a position to understand what offends people of color nor could I ever imagine invalidating someone's personal experience of racism. To say to others, you "shouldn't" be offended to me makes no sense. If people are offended then the name should be changed. If there is any doubt that it could be misconstrued to make others feel as though they are not welcome or included or that this community isn't willing to acknowledge and go through any amount of time, money or effort to make sure everyone feels included then I am sadly disappointed that we moved to this community 10 years ago. When my husband was being relocated to the Bay Area almost a decade ago you could imagine one of our first questions was where can we afford to live. It was important to me that we live in a community with a good public school because I believe such communities value education, which is important to us. When I asked someone living in Marin about how they feel living in a predominantly white area they said, "it's the good white people." I took this to mean Marin is politically liberal, forward thinking and open-minded. We moved from Oak Park, IL where my daughter's kindergarten class had 50% of its children coming from African-American or biracial households, so this was important to us. To me this decision is incredibly important, it will affirm for me that we chose wisely, that this is not a racist community but one that understands the complexity of this issue and the horrific history of a nation that once enslaved black people. It will affirm for me that any reference to the those years can and still does divide us and that we should be very careful to avoid any language (even if it is the name of a school) that promotes such a division.

Dixie Trustees,

First – thank you for your service. I’m sure the last thing you imagined when you signed on to represent our kids and the school district was spending your free time reviewing piles of correspondences and emotional letters and pleas from Dixie School District residents on the Dixie naming issue. Add to that the actions and letters coming from individuals or groups that have never had any real ties or understanding of either our community or schools (e.g., never lived in the district, never had their kids attend our fine schools, never volunteered in our classrooms, never donated to our education foundation) and you definitely have your work cut out for you.

That said, let me get right to the point ---

In nearly 15 years of living in the district (and 10+ of those years working in the service industry within our community), I’ve never had anyone either inside or outside of the district question the name of our 150+ year old school district or somehow tie it to the confederacy. In fact, people contemplating a move to our area would often go out of their way to make sure they would be “*living within the Dixie School District*” – not because they were looking for a place to erect their confederate flag but because they wanted to move to an area whose school district (and its name) was synonymous with academic excellence, tolerance and inclusivity. Simply put, that is what “Dixie” is and has always been.

SO – my experience aside, it begs the question. Can we do better? Is NOW the time to change the name of our established and respected school? I think not and here’s why:

1. **The driving force behind the “Dixie Debacle” is NOT who you were elected to represent.** As you know, the core group of professional activists and publicity seekers leading the effort to change the name have no ties whatsoever to our community.
2. **The tactics utilized by many of those behind the “Change the Name” movement are simply reprehensible. If you vote “FOR” a change at this time, you will send a clear message to the community (and our kids) that taking any means necessary to WIN is OK, as long as you win.** While I recognize there are well-intentioned people on both sides of the equation, the reality is that this entire effort was architected from the beginning and at the top to both bypass and steamroll our community (and a newly appointed board) into submission. **This effort should NOT be rewarded in any way.** That said, I personally have no unwavering attachment to the name “Dixie” and would be open to a name change IF the effort was organically driven and the COMMUNITY came together to change the name. Under no circumstances though would I ever put my support behind a name change effort fueled by a very small group of people trying to use brute force to intimidate the community or weaponize the media against our own school district and its residents.

3. The “media first” strategy utilized by those seeking to change the name speaks volumes of their primary interest: **THEMSELVES**. Ask yourself:

- Who is aggressively pursuing the National Press for media coverage about the name change of our outstanding and inclusive 150+ year old school district?
- Why would they professionally videotape every school board meeting and speaker?
- How does ANY of this benefit our community, bring us together or help kids and our schools?

Leaders of the change the name group have publicly stated an interest in carefully documenting their effort and showcasing themselves since this entire thing is “ripe for a documentary”. Is this really how people selflessly pursuing a cause that is truly important to them behave OR are these the actions one might expect from self-serving activists and aspiring politicians?

4. **15 people (signatures on the various petitions) clearly don’t represent either the voice or creativity of the 14,000+ voters within our district.** If at some point a decision is made by the community to change the name, we can surely do better than the handful of names submitted thus far. Either way, the community must first be heard --- at the voting booth – before this issue is pursued further.

In closing, I would ask that you please make your decisions and cast your vote as a **selfless trustee**, not as a self-serving, aspiring politician.
